

St. Kitts and Nevis Marine Drone Challenge 2021 Consent and Release Agreement

I agree not to file any lawsuit or otherwise make any claim against the St. Kitts and Nevis Robotics Association or the St. Kitts and Nevis Marine Drone Challenge for any such injury or other damages.
